## TERMS AND CONDITIONS

Garburn Small Group Adventures accept bookings subject to the following Terms and Conditions

Please read carefully

### 1. Making a booking

In order to confirm a place on your training weekend you will need to return a completed booking form with the non-refundable deposit (20% of price per person). On receipt of your deposit, we will send you confirmation of your booking along with details of the payment of your balance. The booking is not accepted and no contract is affected until the date shown on the confirmation notice. The balance is due six weeks prior to the training weekend. If you are booking within six weeks of the training weekend then full payment is required at the time of booking. If the balance is not paid by the due date then the booking will be treated as cancelled and the cancellation charges will be apply as detailed below.

### 2. Cancellation by you

If you wish to cancel your training weekend this must be done in writing and addressed to Garburn Small Group Adventures. The following charges will be applied:

- i) More than 6 weeks prior to departure date your deposit will be forfeited.
  - ii) between 6 and 4 weeks prior to departure date a 50% refund of price will be made.
  - iii) Less than 4 weeks prior to departure no refund will be made.
- Any changes made to your booking will be liable to a £20 administration fee.

### 3. Changes or cancellation by us

It is unlikely that we will have to change your booking. However we can make changes to and correct errors in both the website brochure and booking details before and after your booking.

We can cancel your booking, but will never cancel your booking more than three weeks before your training weekend except for reasons beyond our control or if you do not pay the final amount. If we cannot provide the weekend you have booked for the reasons hereinafter mentioned you will have a choice of either placing another booking with us, paying or receiving a refund of any price difference, or you can receive a full refund of all the money you have paid us. We will not cancel your training weekend unless required to do so as a result of circumstances beyond our control:

- i) Unforeseeable circumstances: industrial disputes, war, natural disaster, adverse weather conditions.
- ii) the minimum number required to operate the training weekend not being reached.

If any training weekends are cancelled we will not accept liability for any damages whatsoever incurred as a result.

### 4. Insurance

All customers should ensure that they are covered for any cancellation or medical occurrence. Also please ensure that any insurance policy you have covers you for any optional activities that you may want to participate in. Please check with your insurer.

### 5. Your responsibilities

Your booking is accepted on the understanding that you realise the inherent risks and hazards of the training weekend, and agree to take responsibility for your actions and own safety.

On our training weekends it is necessary that you agree to abide by the authority of your guides who will be working to ensure the safety and welfare of the group. Any action to jeopardise this may result in you being asked to leave the trip with no right to refund or any compensation.

Special requests and any medical issues or conditions, must be brought to our attention at the time of booking. We cannot be held liable for any action or events, which could have been avoided with proper disclosure of information.

Personal property is always your own responsibility.

Smoking is not permitted in any vehicle or in any accommodation.

### 6. Our responsibilities

Garburn Small Group Adventures responsibilities only starts at the designated meeting point and time. We cannot be held liable for any expense or inconvenience before that, or as a result of you failing to join the group on time.

We shall not be held liable for any loss caused by the total or partial failure to carry out the contract if it is;

- i) Attributed to a customer
- ii) Unforeseeable or unavoidable and attributed to a third party unconnected with Garburn Small Group Adventures
- iv) As a result of events which Garburn Small Group Adventures could not have foreseen even exercising due care.

### 7. Prices and Surcharges

Garburn Small Group Adventures will not impose surcharges on the price of your training weekend within 30 days prior to the date. We reserve the right to impose surcharges before this to cover increases in transportation costs, dues, taxes or government action. If the surcharge amounts to more than 10% of the total training weekend price you will be entitled to a full refund of all monies, provided that the cancellation is done within 2 weeks of the surcharge notification.

### 8. Itineraries and training weekend details

The nature of the training weekends requires a flexible approach to stated itineraries and all participants should accept this flexibility and acknowledge that delays and alterations, and their results (such as inconvenience and disappointment) are possible.

No refund or compensation will be given for unused transport, accommodation or services.

All details are accurate at the time of going to press, and any significant alterations will be brought to your attention at the time of booking.

### 9. Complaints

Any problems or complaints about your training weekend should be raised with your leader at the earliest opportunity, and they will normally be rectified or appropriate action taken. If you require further action on return we will try and work towards an agreed settlement, but you must notify us in writing within 21 days of the completion date of your training weekend.

### 10. Legal Code

All terms and conditions are made subject to, and enforced by English law and must be done so in English court.
